Addendum to the Scheme Information Document of IDFC Interval Fund – Series 4
SPECIFIED TRANSACTION PERIOD (“STP”) OF IDFC INTERVAL FUND – SERIES 4

The Specified Transaction Period (“STP”) of IDFC Interval Fund – Series 4 (an Interval Income Scheme), is scheduled from Friday, [#]May 02, 2014 to Monday, May 05, 2014, during which subscriptions and redemptions (including switches) in the Scheme will be permitted.

During the STP, the transaction requests (subscription/ redemption/switch) will be accepted by the Mutual Fund during normal business hours on May 02, 2014 and only up to the cut-off time (3.00 p.m.) on May 05, 2014. The NAV applicable will be as per the cut-off timing prescribed based on the date and time of receipt and value of the application.

The subsequent STP for this interval period will be on [#]August 04, 2014 & August 05, 2014.

INDICATIVE ASSET ALLOCATION FOR THIS INTERVAL:

Post closure of this STP, the Scheme shall invest in the below mentioned securities within a range of 5% of the intended allocation (floor and cap) mentioned against each sub asset class/credit rating, till the onset of the next STP.

1. The Fund manager shall reserve the right to improve the portfolio credit quality by deviating from the asset allocation in favour of higher credit rated instruments in the same category of instruments at the time of launch of the scheme.
2. All investment shall be made based on the rating prevalent at the time of investment. However, in case of an instrument having dual ratings, the most conservative publically available rating would be considered.
3. In the event of any deviations from the floor and ceiling of credit ratings specified for any instrument, the same shall be rebalanced within 5 days from the date of deviation. Such changes in the investment pattern will be for a short term and for defensive consideration and the intention being at all times to seek to protect the interest of unitholders.
4. In case of non availability and taking into account the risk reward analysis of NCDs and CPs the scheme may invest in treasury bills, cash management bills, CBLO or bank CDs of highest credit rating i.e A1+. Such deviation may exist till suitable NCD/CP of desired credit quality are not available.
5. The scheme shall not invest in repo in corporate debt securities.
6. Gross exposure to debt, money market shall not exceed 100% of the net assets of the scheme.

7. The scheme shall not invest in real estate, airlines and telecom sector.
 8. The ratings mentioned shall include the modifiers (+/-). E.g., the ratings AA, A mentioned above shall include AA+ / - or A+/- respectively.
 9. At the time of building up the portfolio and towards the end of the maturity of the scheme, the portfolio may have higher allocation to cash and cash equivalent instruments.

If in any case the Specified Transaction Date/Period falls on a non-business day, the immediately following business day shall be deemed to be the STP.

Contents hereof shall respectively form an integral part of Scheme Information Document & Key Information Memorandum of the Scheme and all other features/terms & conditions as mentioned therein shall remain unchanged.
